

PAYMENT & CANCELLATION POLICY

Debit/credit card details and/or voucher reference are to be taken at the time of booking.

Spa treatments and packages are then to be paid in full upon arrival at eforea spa on the day on which the treatment or package is to be enjoyed.

Please note, any spa packages cancelled within 28 days of the date for which they were booked and any spa treatments cancelled within 72 hours of the date for which they were booked will be charged at 100% of the service price.

ARRIVAL & FACILITIES

Please note, treatment times and facility usage commences from 10am.

We recommend that you arrive to check in at our eforea spa's lounge reception at least 30 minutes prior to your scheduled appointment.

Any late arrivals could mean that your scheduled treatment may be reduced or cancelled. If cancelled, the cancellation policy listed above will still apply.

If you are on a spa day package, you are more than welcome to arrive from 9.30am, whilst departure will be at 5pm.

Any discrepancies regarding a spa treatment or package must be notified upon redemption/use.

FOOD & BEVERAGE

Any meals that are included within a spa package can be pre-booked in advance.

All other food and drink can be pre-ordered upon arrival on the day of your scheduled spa package/treatment.

Please note, only food and beverage purchased on-site at eforea spa may be consumed on the premises.

SPA ATTIRE & ETIQUETTE

Swimwear is compulsory within the wet area.

Upon arrival we will provide you with a robe, towel and slippers. Please note, you will be provided with one set of slippers, a robe and towel per visit, an additional charge will apply if you require extra.

You will have use of our lockers within the changing facilities.

If utilising our transition lounge and deep relaxation room we request that you are warm and dry, so as to maintain yours and any other guests' comfort.

To preserve the serenity of the eforea spa, upon which we pride ourselves, there are no mobile phones, tablets or recording devices permitted within the spa area and we request that guests keep noise to a minimum.

eforea spa operates a strict no smoking policy, both within the spa itself and on its external terrace. Please note, this policy also applies to electronic cigarettes and vapes.

HEALTH & WELLBEING

The minimum age for all spa treatments, packages, spa days and spa breaks is 16.

We advise that our hydrotherapy pool, steam rooms and sauna facilities are not used during pregnancy or if you are under medical supervision of any kind.

Please advise us at the time of booking if you are pregnant or undergoing any medical treatment so as that we can suggest suitable spa treatments and packages.

Please note, you will be required to complete a consultation form upon arrival at eforea spa.

FACILITY USE

Guests visiting eforea spa for a treatment who haven't booked spa facility usage can do so for just £25 Monday - Thursday and £35 Friday - Sunday. This would then entitle them to make use of the facilities within eforea spa for two hours on the day of their treatment.

FITNESS SUITE

All spa packages, days and breaks entitle the use of our on-site fitness suite for the duration of your visit.

Guests who have upgraded to full use of eforea spa's facilities are also entitled to make use of our fitness suite.
